### Wireless is Toxic Pollution!

\* 4G/5G Wireless antennas transmit pulsed, data-modulated, Radio Frequency Electromagnetic Microwave Radiation (RF-EMR) 24/7, which is harmful to all living organisms: people, animals, insects and plants.

### Our Mission

\* To educate our communities and elected officials on the biological harm, and the violations of our right to privacy and bodily autonomy posed by wireless radiation, including Wi-Fi.

\* To expose the agenda behind the push to put 5G in everyone's business and home.

\* To facilitate community involvement in our municipalities and counties to adopt protective telecommunications ordinances for our neighborhoods, schools, homes and workplaces.

\* Thousands of studies have documented biological harm from exposure to radio frequency and microwave radiation from wireless communications. A ten-year \$25 million study by the National Institute of Environmental Health Sciences found that cell phone radiation caused tumors in the heart and brain of rats, as well as in the adrenal system, pituitary gland, thyroid, pancreas, skin, lung and liver. DNA damage was also found, along with low birth weight and other perinatal changes in animals. <sup>3</sup>

**EHT/CHD v FCC, Case 20-1025:**  
**(11,000 pp of studies presented)** <sup>6</sup>  
Federal Communications Comm. (FCC)  
Must Update Wireless Safety Standards  
(8/13/21)

### The FCC was court ordered to:

\* Provide a reasoned explanation why it hasn't updated its testing procedures,

\* **Address the impacts of RF radiation on children**, the health implications of long-term exposure to RF radiation, and the ubiquity of wireless devices, and

\* Address the impacts of RF radiation on the environment.

### Mandate the FCC to Comply!

On April 4, 2023, Children's Health Defense (CHD) petitioned the FCC to comply with the above-mentioned court-ordered mandate. To date, the FCC has failed to comply. <sup>7</sup>

Allowable limits for exposure to radio-frequency and microwave radiation in the U.S. are 45x higher than they are in Russia.

### Wireless radiation limits by country

Japan	600 microwatts/cm2
<b>U.S.A.</b>	<b>450 microwatts/cm2</b>
Canada, France, Germany	450 microwatts/cm2
India	45 microwatts/cm2
China	40 microwatts/cm2
Russia	10 microwatts/cm2
Italy, Bulgaria, Poland	10 microwatts/cm2
Ukraine	2.5 microwatts/cm2
